SPECIAL MEETING - WOLCOTT TOWN BOARD - September 26, 2022

A Special Meeting (Budget Workshop) of the Wolcott Town Board was held Monday, September 26th, 2022, at 6:00 PM at the Wolcott Town Hall with the following people present:

The Supervisor called the meeting to order at 6:00 PM.

Pledge of Allegiance -

The purpose of this special meeting is to discuss the Tentative Budget for 2023 and any other business that might come before the Board.

OTHER BUSINESS -

1. There was an error on the September abstract, and it was missing Time to Spare, the cleaners for the Town Hall.

ABSTRACT OF CLAIMS -

GENERAL ACCOUNT - Claim #294 - total - \$260.00

A resolution was presented by Adam Ellis, moved by Jorden Brown, seconded by Ray Hauss "Be it RESOLVED to pay General account claim as presented."

VOTE - AYES <u>5</u> NAYS <u>0</u>.

<u>2023 TENTATIVE BUDGET</u> – Amber started off explaining the various changes to the line items from the previous year in the tentative budget and discussed the two options of the budget she gave to the Board. She said she is waiting for a few more things to come out before she can get all the final numbers. Amber said she had a few questions for Roger about the decrease in the Court Contractual account but would ask him to clarify later. There was a question from Adam about the Cemetery line, Amber explained that next year if cemetery bids come in higher and/or an increase in weed harvesting that we should be prepared for it. After a quick discussion the Board moved to talk about salaries. Roger discussed the contractual questions with the Board and Amber, Roger moved onto speaking about his Clerk, Mary Anne and her position, Mary Anne then spoke to the board about her requested increase, there was a lengthy discussion, and it was determined not to increase anyone's salary and to keep in line with the highway contract increases.

2023 TENTATIVE BUDGET – (cont'd)

Adam inquired about the Assessor's Clerk extra education, she said she was very close to obtaining her Assessor's Certification, the Board decided due to her seeking additional classes and knowledge they would increase her hourly rate to \$17.00. There was more discussion about the budget items between the Board. Zach mentioned that he will have to look for a part-time employee for the Highway Department for this upcoming year and pay will be a discussion when he starts looking.
